The Parent desires for their child to work as a volunteer for MUST Ministries, Inc. and engage in the activities related to being a volunteer (the "Activities"). The Parent hereby freely, voluntarily, and without duress executes this Release under the following terms:

Release and Waiver. Volunteer does hereby release and forever discharge and hold harmless MUST Ministries, Inc. and their successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Volunteer's Activities with MUST Ministries, Inc.

Parent understands that this Release discharges MUST Ministries, Inc. from any liability or claim that the Parent may have against MUST Ministries, Inc. with respect to any bodily injury, personal injury, illness, death, or property damage that may result from Child's Activities with MUST Ministries, Inc., except where directly caused by the gross negligence of MUST Ministries, Inc. or its officers, directors, employees, or agents or otherwise. Parent also understands that MUST Ministries, Inc. does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness.

Medical Treatment. Parent does hereby release and forever discharge MUST Ministries, Inc. from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Child's Activities with MUST Ministries, Inc.

Assumption of the Risk. The Parent understands that the Activities include work that may be hazardous to the Child, including, but not limited to, construction, loading and unloading, and transportation to and from the work sites.

Parent hereby expressly and specifically assumes the risk of injury or harm in the Activities and releases MUST Ministries, Inc. from all liability for injury, illness, death, or property damage resulting from the Activities.

Insurance. The Parent understands that, except as otherwise agreed to in writing, MUST Ministries, Inc. does not carry or maintain health, medical, or disability insurance coverage for any Child. Each Parent is expected and encouraged to obtain his or her own medical or health insurance coverage.

Photographic Release. Parent does hereby grant and convey unto MUST Ministries, Inc. all rights, title, and interest in any and all photographic images and video or audio recordings made by MUST Ministries, Inc. during the Childs's Activities with MUST Ministries, Inc., including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.

Confidentiality. Volunteer agrees to treat the identity and all information about clients, as well as other identifying information about the shelter, transitional houses, or any other services as confidential. Clients' names will not be mentioned outside the structure of our programs. Cases will not be discussed with any person other than a MUST staff member, unless specifically authorized by the client. I certify on behalf of the minor child that I have an understanding of Sexual Ethics and Sexual Harassment

Other. Parent expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Georgia, and that this Release shall be governed by and interpreted in accordance with the laws of the State of Georgia. Parent agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
